

AEBR GENERAL ASSEMBLY AND ANNUAL CONFERENCE 2010

The AEBR Award "Sail of Papenburg", which was endowed by the Ems Dollart Region on the occasion of the *AEBR Annual Conference 2002 in Papenburg* (Ems Dollart Region), will be bestowed also in the year 2010.

The motto for this year's award is:

"Territorial Cooperation in a Post-Crisis Scenario. Contribution of CBC."

2nd AEBR Summer Seminar for Border Youth, 19 - 23 July 2010, Trieste

For this year's Youth Seminar, organised by the Autonomous Region of Friuli Venezia Giulia and the AEBR Task Force of External Borders, 10 applicants were selected by the TFEB jury. They come from different European countries: Belgium, Russia, Slovenia, Moldova, Ukraine, Romania, the youngest participant is 22 years of age, the oldest 27 years.

The aims of this seminar are manifold: To provide the youth information on study possibilities abroad in other border regions, to work on principles of cross-border cooperation on the European, regional, and local level, and to encourage the universities in the external borders to be more international and to provide international studies. As stated by Urpo Moisis, Chairman of the TFEB, "It is more likely, that a young person, who goes to

study in another border region, will return back to benefit his/her own region. This is if we compare to the youth going to study in the capitals".

One of the participants, Ms. Elena Itani, already participated for the second time and therefore also acted as a tutor.

The forum is supported by *Erdisu*, the *Programme for territorial cooperation of Italia and Slovenia*, the *Italy-Austria Interreg IV programme*, the *UNESCO Centre in Trieste*, and *TRIESTE TRASPORTI S.p.A.* for local transfer.

CoR Opinion on “Reinforcing Economic Policy Coordination”

AEBR Executive Committee Member, Mr Konstantinos Tatsis, has been appointed by the Committee of the Regions as Rapporteur for the opinion on “**Reinforcing Economic Policy Coordination**”.

The opinion is a response to the European Commission communications COM(2010) 250 and COM(2010) 367 which aim at finding a remedy to the weaknesses in the functioning of the existing framework for the economic policy co-ordination at the European level. The European Commission argues that since its introduction in 1999 the implementation of the Stability and Growth Pact has been seriously hampered by the lack of consequent application and that to tackle the shortcomings in the co-ordination of economic policy, a new approach and

a new framework for better, more efficient and productive co-ordination of economic policies is needed.

The approach is based on stipulations primarily concerning the members of EUROZONE, however, the economic rules are relevant for all the economies of the European Union.

As part of the preparations for the CoR opinion on this topic the rapporteur, **Mr Konstantinos Tatsis**, member of the CoR ECOS Commission, and his expert, **Ms Anastasia Panopoulou** held a meeting with representatives of the associations of local and regional authorities and other stakeholders for a consultation and exchange of views on his opinion. This consultation took place at the Committee of the Regions on

Tuesday 27 July.

The consultation focused on the fact that in order to achieve its objectives, the coordination of economic policy has to proportionally involve the regional and local authorities, particularly with regard to the competencies in the area of budget and consequently all the policy areas for which the budgetary implications are crucial; such as for example education, public procurement and SME support policies.

Furthermore, the role of local and regional authorities in the policies within the EU2020 strategy and within the context of the programming of the European Semester were explored.


